

EXPORT SANCTIONS ON RUSSIA

Dear Customers,

Following the decision of Russian Authorities on August, 7th 2014 to ban certain commodities (appendix 1) from EU countries, Norway, USA, Canada and Australia, Austromar would like to inform you about the following:

- As per Federal Customs order banned goods that were discharged on Russian territory after Government order must be immediately evacuated from Russian territory.
- Austromar will therefore not discharge any container containing banned commodities ("banned containers") onto Russian territory at St. Petersburg, Ust Luga or any other port.
- Austromar will proceed to returning these "banned containers" to the port of loading on which the container was loaded on board of any kind of Vessels.
- Costs related to returning "banned containers" will be passed forward to our customers. We therefore respectfully recommend that you would adequately inform your good selves and closely follow-up on these developments and the corresponding rules and regulations so as to avoid the shipment of sanctioned cargoes into and/or out of the Russian Federation. It might be useful for you to liaise with your underwriters in order to ensure that you maintain insurance cover.
- Our customer service staff have been briefed about how to act and will keep you informed about the situation of each "banned container"
