Austromar will process your personal data for the purpose of providing our services and products in accordance with applicable law and your personal data will be stored only for a period required by law after termination of the service. We will update its processes, policies and systems to safeguard your privacy also in the future to meet the legal regulations.

In view of the contractual nature of the relationship between Austromar and you – the customer, the providing of your personal data is entirely voluntary.

However, Austromar cannot enter into a contract or provide a service and products unless your personal data necessary for the conclusion of the relevant contract or service are provided to us by you. Austromar will forward your personal data to abroad only if it is inevitable for executing the particular service. All persons who come into a contact with your personal data in the performance of their work or contract obligations are bound by a statutory or contractual duty of confidentiality.
